



## Energise Barnsley Community Fund 2018/19

Individuals and organisations from the Barnsley area can apply. Proposals must meet all of the following criteria in order to be eligible for consideration:

- The proposal aligns with at least one of the aims of the Society
- The amount of the funding requested is at least £250
- The funds are being used for the benefit of the local community to meet a demonstrable local need
- There is a defined impact from the use of the funds
- Projects will be delivered within the Barnsley region for the benefit of its residents.

To make sure that your funding idea is eligible for the grant application please read the Society Rules and Objectives of Energise Barnsley – overleaf. Your funding request must adhere to one of the aims of the Society.

Each recipient of the Fund is required to report annually on the impact they've achieved via a short online survey and a summary report on the activities they have delivered with the Fund's support. A selection of the reports will be used as case studies in the Energise Barnsley annual report.

To apply for the 2018/19 fund please use no more than 500 words to briefly describe your project, the amount you are requesting to be funded, a breakdown of what the funds will be used for, and how you will measure and report on the impact the funding has had. Please also confirm the status of your organisation, with company registration or charity number, or mutual number.

The deadline is 30/11/2018. The fund for 2018/9 is £10,000. The board of Energise Barnsley will make award decisions shortly after the deadline and inform successful applicants.
